TERMS AND CONDITIONS

Enrollment is subject to the following terms and conditions as well as availability of space.

- I, the parent/guardian understand that the camp agrees to provide all the services as outlined in the camp literature.
- I, the parent/guardian understand that my daughter might have to participate in language class depending on her ability in French. See parent guide www.ouareau.com
- I, the parent/guardian understand that my daughter's participation in sailing, windsurfing, canoeing, kayaking and canoe trips depends on her swimming ability as judged by the camp, and my daughter might have to participate in swimming lessons depending on her ability. See parent guide www.ouareau.com
- I, the parent/guardian enclose a payment (cheque, money order, cash, bank transfer or credit card payment authorization) for \$500.00(2 week session and over) and/or \$100.00 (Junior Camper session) as a deposit for each of my daughter's application's dated today, which will be returned if this application is not accepted. I understand that \$150.00(2 week session and over) and/or \$30.00(Junior Camper session) of this deposit **is a non-refundable administration fee**, once my daughter's application is accepted. If withdrawal from the camp session occurs on or before March 1st, 2012, all amounts paid, other than the non-refundable \$150.00 and/or \$30.00 administration fee, will be refunded. **The full deposit is not refundable after this date.** The balance of camp fees is due and payable in full on or before May 1st, 2012. A post-dated cheque/credit card payment authorization for such balance dated May 1st, 2012 is required upon confirmation of my daughter's place. **No refund of camp fees will be made under any circumstances after May 1st, 2012.**
- A formal acceptance will be mailed and/or e-mailed to the parent or guardian to confirm enrolment.
- There is no reduction or refund of camp fees for campers arriving late or leaving early in any period for which they are registered.
- I understand that the director has the right to require a camper to withdraw for the following reasons: not following either the community contract (D.A.R.E.) or camp regulations or in the case of gross misconduct, in which case the balance of the fees is forfeited. An example of the community contract, camp regulations and a list of gross misconducts is available on our website or by request to the camp office. Note, that the community contract (D.A.R.E.) changes slightly each season.
- If any payment is received in a currency other than Canadian Dollars, then conversion into Canadian Dollars shall be made at the time of deposit at the prevailing rate of exchange available to the camp. If the amount of Canadian Dollars received by the camp following such conversions is less than the required fee, then I shall immediately pay such additional amounts as may be necessary to ensure that the full fee in Canadian Dollars is paid.
- If the camper has a potentially life-threatening allergy or food sensitivity, the parent or guardian must contact the camp office prior to completing the form. **Please note that Camp Ouareau is NOT a peanut-free environment**
- I understand that Camp Ouareau is an un-plugged environment and that my daughter can't bring to camp electronics such as i-pods, cell phones etc.). Camp provides all campers with a DVD with more than 500 photos of their stay at camp. We encourage campers not to come with their own cameras.
- Tuck shop, transportation to and from camp, medical charges, canoe, kayak, climbing and hiking trips and swim tests are charged as used.
- To the best of my knowledge, my child is in good health. I understand that I can't bring my daughter to camp if she is showing or has been in contact with someone showing any of the following symptoms; cough, runny nose fever, vomiting or diarrhea. I understand that if she exhibits these signs upon arrival or during her stay at camp, she will be sent home until she has been symptom-free for 48 hours. I understand that there is no reduction or refund of camp fees for campers having to return home due to illness.
- I understand that I must check my daughter for lice and nits immediately prior to coming to camp. If my daughter arrives at camp with nits and/or lice and has not been treated for the condition, camp reserves the right to send her home until cured of the condition.
- Camp Ouareau is not responsible for any loss or theft of the campers' property.
- Any deviation from the foregoing is at the discretion of the Camp Director.

Unless I the parent/guardian, advise you otherwise in advance in writing, I approve my child's participation in all camp programs and activities, acknowledging that such participation involves risks and hazard incidental thereto, all of which are expressly assumed by me, and do hereby waive, release and absolve and agree to indemnify and save harmless Camp Ouareau Inc. and its officers, directors, employees, volunteers and agents from any and all liability arising, therefrom, except such as shall arise solely as a consequence of its or their gross negligence or willful default. If for any reason my child requires medical attention or special medication beyond that furnished by the camp, I agree to be responsible for any expenses incurred. I grant Camp Ouareau permission to use any photos taken of my child in its promotional materials.
